International Public Health/International Health: Access Initiative: Free the Vaccine for COVID-19 Campaign: For this second COVID year, in partnership with the Center for Artistic Activism, our creative campaign has attracted a diverse group of people in over 30 countries aged 17 to 72. During COVID-19 we have increased our active base of supporters by 700% through building community via our online advocacy labs for Free the Vaccine for COVID-19. Medical students work alongside experienced artists and end to experiment with innovative actions, learning through iteration and reflecting on what worked and what didn't. Many of these participants are starting from zero and ending with deep knowledge of the biomedical research and development process and confidence in their ability to use creativity and culture to improve it. The Advocacy Innovation Labs represent unique leadership training through collaborative, experimental, non-hierarchical, global actions. Through this kind of organizing we have a mechanism for building and strengthening community power. May 5th, 2021 was an historic day not just for our Free The Vaccine for COVID-19 campaign but for our entire movement. At the end of our rally for 'vaccine access for everyone, everywhere' on the National Mall; we were informed that the U.S. government would indeed support negotiations on the TRIPS Waiver. As we work to shift the global research and development model to be more people-centered and needs-driven rather than focused on benefiting shareholders this was an important step in that direction. Further action however must be taken if it is to save lives and increase global access to COVID-19 medicines. On October 28th 2021 UAEM students and staff supported the organizing for a protest led by allies Peoples Action in Washington DC to call on world leaders at G20 1) lift vaccine patents and share the technology to allow ALL countries to develop their own vaccines and 2) equitably redistribute surplus vaccines in high income nations. The rally was covered on the front page of Democracy Now. The image that was selected was of our Free the Vaccine banner with Sharing is Caring held up by students in Care Bear costumes. Covid-19 Public Funds Mapping Tool: On April 15th 2021, UAEM launched the second iteration of the COVID-19 Mapping Tool, a powerful and dynamic instrument demonstrating the depths and reach of taxpayer funds in the development of coronavirus-related medical technologies and vaccines. The new data on the updated website visualizes and articulates how public funds are being directed and spent for COVID-19 research into vaccines, treatments and diagnostics. The first iteration of the mapping tool was released in May 2020 in immediate response to the rapid injection of public money all over the world to accelerate the COVID-19 response. The update includes new data, additional countries, methodological refinements, and website features. UAEMs analysis boldly emphasizes the crucial role of public funds provided to public research institutions to innovate health technologies against COVID-19. The World Health Organization (WHO) recognized the value of our Mapping tool and added it to the WHO's Databases on inputs to R&D. UAEMs global team has been working on this initiative over the past 15 months as part of our campaign to ensure publicly-funded COVID-19 diagnostics, therapeutics and vaccines are accessible and affordable to all. The White Paper to accompany the report can be found on the homepage of the website:

Form 990, Part III, Line 4b:

Medical Specialties Research: Innovation Initiative: In April 2021, we launched the latest version of the University Report Card, a critical study of the top sixty research universities in the US scrutinizing their biomedical research and development (R&D) policies, practices, and performance in domestic and neglected global public health needs in access to medicines, including their COVID-19 response. Universities were graded in the following categories: Access, Innovation, Empowerment, and new this year Transparency and COVID-19. The new COVID-19 section focused on global access licensing policies related to COVID-19 including confirming which universities had signed the Open COVID Pledge or supported the COVID Technology Access Pool (C-TAP). The answer, more than one year into the pandemic and over a year of campaigning has remained at zero universities signing onto these essential WHO mechanisms. This is further evidence of universities' for-profit approach to technology transfer and why the work of UAEM is critical to disrupting the existing model which serves as a barrier to access to medicines. As of publishing, of the sixty research universities, only two institutions have received the highest grade). A stark contrast to the majority of failing grades, even with a generous grading curve. Below are some of the key findings from the report: Fifteen percent of universities devoted no research funding to global health research; most devote 1-5%. Fifteen percent of schools devoted no medical research funding to neglected diseases; most devote 0.51-1.0%. Between 11% and 30% of university biomedical research is published in open-access journals. NO universities reported having policies that require researchers publish all the results of their clinical trials. Half of the universities have made no commitments to equitable COVID-19 biomedical licensing practices. With the release of the new Report Card our chapters will have updated tools at their disposal for further 2022 advocacy. The ranking and breakdown of their scores are available on the Report Card website: <https://globalhealthgrades.org/> Further, building on the successful launch of the first iteration of the report Clinical Trials Transparency and the role of US Universities, our follow-up report was launched in May 2021 and highlights the significant improvements in university reporting rates, largely due to advocacy by UAEM and our allies, while also reminding researchers and the larger public why this issue is important, using the COVID-19 pandemic as one example case. The timely disclosure of results helps to improve public health outcomes over time by reducing waste in research, increasing efficiency in the use of resources, limiting reporting bias and contributing to enhanced decision-making. Clinical trial transparency is critical for physicians to make informed decisions when prescribing medicines and for researchers to avoid duplicating studies. Successes highlighted in the report include: the increase in number of research institutions legally compliant under FDAAA (100% of clinical trials reported) from 13 to 17, the increase in total number of registered clinical trials from 446 to 1516 between February 2019 and February 2021, The decrease in total number of unreported trials from 138 to 101. The findings of the report and microsite www.altroute.com/clinicaltrials were covered in STAT NEWS among other news outlets. In 2021 UAEM also partnered with the New York University (NYU) Technology Law and Policy (TLP) Clinic to file Freedom of Information Act (FOIA) requests with the Food and Drug Administration (FDA) and National Institutes of Health (NIH) regarding clinical trial enforcement. For the first time ever, the FDA issued a warning to Acceleron Pharma, Inc., a developer of experimental kidney cancer treatment. FDA's Notice of Noncompliance is the first time any more meaningful enforcement action has been taken by either FDA or NIH. The company was notified after failing to submit their Phase 2 drug trials from last year. In our ongoing investigation as part of our strategy to increase university compliance with FDAAA we have gathered evidence that over an eight-year period the FDA only sent a few dozen pre-notice letters to non-compliant sponsors suggesting they come into compliance. Going forward this advocacy work will continue at the chapter and national levels as part of our ongoing campaign to push universities to achieve 100% compliance in clinical trials transparency and become leaders in pushing for a more open and transparent biomedical R&D system.

Form 990, Part III, Line 4c:

International Public Health/International Health: Empowerment Initiative. The UAEM North America Annual Conference was held virtually on October 2021 under the theme Student Response to Racial Inequity in Access to COVID-19 Medicines. The conference was organized and hosted by UAEM Chapters at Washington DC, Maryland and Virginia (DMV) Universities in Washington DC. Over 100 students, allies, professors and experts in global health from around the world attend the virtual conference. As in the previous years, the conference continued to focus on student-driven campaigns, skills-building training and organizing for action in the Covid-19 climate, while retaining expert-level panels and speakers. This year we had a powerful keynote panel infused with joy and fun filled learning. The panelists included Ruqaiijah Yearby, Professor of Law and Member of Center for Health Law Studies, Fatima Hassan, Founder & Director of Health Justice Initiative and Priti Krishtel, Co-Founder and Co-Executive Director of I-MAK. The conference also provided student-driven panels focusing on activities for both new and veteran UAEMers, with an emphasis on skills-training specific to our ongoing Free the Vaccine for Covid-19 campaign, our initiatives on alternative R&D, and UAEMs University Report Card project, and breakout sessions on how to use UAEM Mapping tools, Social Media as an Advocacy Tool, and Fake Pharma vs The People led by Peter Maybarduk, Public Citizen and one on Access to Insulin - #100YearsOn led by Molly Lepeska, Health Action International/ACCISS Study. Our goal was for students to leave the conference not only with increased knowledge and inspiration but with tangible and actionable skills to take back to their campuses and put into practice through targeted campus activities and beyond. UAEM also continued to collaborate with our expanding network in Europe, Brazil, Colombia and other areas, and continued to provide global health leadership opportunities and experience through campus initiatives and service on UAEMs Coordinating Committee, Board of Directors, Global Governance Council and other positions to ensure global UAEM cooperation, collaboration and representation.
