The range and overall pool is reviewed and approved by the Board of Trustees. The amount designated for the CEO and CFO are considered in the compensation consultant's analysis of executive compensation.

SNHMC uses a compensation committee, independent compensation consultant, a compensation survey, and approval by the board or compensation committee to establish the compensation of the organization's CEO.
Unrelated Organization Compensation	Marc Sadowsky, who serves on the Board of Directors for Foundation Medical Partners, is also the Medical Director of Southern New Hampshire Medical Center's Electro Convulsive Therapy (ECT) unit. During Calendar year 2020 the Medical Center paid New England Neurological Association \$12,600 for ECT and \$26,800 for weekend coverage provided by Dr. Sadowsky to Southern New Hampshire Health System.
