Annually, the Foundation's board of directors determines the level of grant making based on two factors that serve to stabilize annual spending levels and preserve the real value of the endowment over time. In fiscal years 2017 and 2016, those factors are 70% of the prior year's spending, adjusted for inflation, plus 30% of a spending rate at 6.4% for 2017 and 2016 of the estimated fair value of its discretionary endowment.
