**Explanation:** The 2021 Form 990-EZ was filed on time but not electronically. It was received by the IRS on May 2, 2022 but was not processed and returned as an incomplete return since it was not filed electronically. After the IRS returned the 990-EZ, the President and Treasurer contacted their CPA and asked to have the return filed. After a 2 week period, the CPA informed them that he couldn't prepare and file a non-profit return. The President and Treasurer made good faith attempts to find an organization which would file the return. None would. Unfortunately, the CPA's and tax businesses contacted by the President and Treasurer neglected to inform them about the process involved in filing a return. They were not informed that the return has to be prepared by a firm, reviewed and filed electronically. They prepared the return and were looking for a business just to file the return. They were not informed by anyone that the return was required to be efiled. The President and Treasurer are asking that no penalty charges be applied for this return. They prepared the return and sent it off in a timely manner. This is a small non-profit providing events for the elderly. They are dedicated to the cause and have consistently helped our elderly friends.
