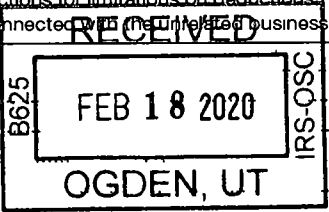

STATEMENT 1

THE ORGANIZATION IS AMENDING THIS RETURN TO EXCLUDE QUALIFIED FRINGE COMMUTER BENEFITS THAT WAS ADDED TO UNRELATED BUSINESS INCOME ON THE ORIGINAL RETURN. THE "FURTHER CONSOLIDATED APPROPRIATIONS ACT OF 2020, SIGNED INTO LAW ON DECEMBER 20, 2019, EFFECTIVELY STRIKES SECTION 512 (A)(7) FROM THE INTERNAL REVENUE CODE, WHICH DISALLOWED DEDUCTIONS FOR EMPLOYERS WHO PROVIDE COMMUTING FRINGE BENEFITS FOR EMPLOYEES.

AS A RESULT OF THE NEW LEGISLATION, THE ORGANIZATION IS REQUESTING A REFUND FOR THE TAX PAID.
