PREVENTION AND EDUCATION (P&E) AN INTEGRAL PART OF NORTHPOINTE COUNCIL'S PREVENTION & EARLY INTERVENTION EFFORTS, THE PREVENTION EDUCATION PROGRAM PROVIDES A WIDE RANGE OF SERVICES DESIGNED TO PROMOTE RESPONSIBLE CHOICES REGARDING ALCOHOL & OTHER DRUG USE, TO EDUCATE THE COMMUNITY ABOUT ALCOHOLISM & ADDICTIVE BEHAVIORS, PARTICULARLY THAT THERE ARE PREVENTABLE & TREATABLE HEALTH ISSUES. INDIVIDUALS WHO ARE INTERESTED IN ATTENDING DDP CLASSES MAY SIGN UP FOR THE PROGRAM THROUGH A LOCAL DEPARTMENT OF MOTOR VEHICLES OFFICE.
