Orphans Hope Asia: The civil war that started February 1, 2021 has had a tremendous impact and caused great suffering in the country. We have continued to provide orphans with food, clothes, medical care, improvements in living conditions, and other essential needs, which have been greater than ever. Food relief has continued to be a significant need in 2023 and we have been able to help many orphanages struggling for food as their normal sources of support have been cut off. In the face of schools being closed we hired teachers and are teaching English, math, computers, agriculture, life skills at Ophan's Hope orphanage. We improved living conditions and expanded self-sustaining food resources with gardens and planting of fruit trees. We held a Christmas celebration for almost 1,000 orphans but camps and interntional volunteer teams were not possible due to civil war.

Form 990, Part III, Line 4b:

Orphan's Hope Ukraine: The war in Ukraine has caused a lot of challenges and suffering within the country. In the midst of this, we assisted with evacuation, food, and humanitarian assistance to orphanages and people fleeing the war. We continued to serve orphans in the orphanages, foster families, and graduates from orphanages. We held IT classes for young people in the Kiev region and counseling for vulnerable teens and families at risk. We also provided mentoring and life skills classes for two groups of teens.

Form 990, Part III, Line 4c:

Pakistan: We provided for the monthly food, clothes, school, and medical needs of a very poor orphanage with 25 children. We continued to renovate to improve conditions, giving the children a better to live. We also continued the construction of Hope Market aimed at enabling the orphanage to be self-sustaining with 100% of profits going to care for the children, enable them to go to school, and improve their home.
