Every Balboa Park employee, volunteer, and trustee has an opportunity to participate in the development and implementation of BPCPs One Park - One Team programs including: Sustainability, Advocacy, Parkwide Communications, Learning Institute, Multi-organization Explorer Passes, San Diego Maker Faire, Community Access Passes and Military Appreciation Passes. OTHER PROGRAM SERVICES 5: Program Events (San Diego Maker Faire): This multi-museum event showcases innovation, creativity, and hands-on learning for adults, teens, and kids in the San Diego region. It is an all-ages gathering of tech enthusiasts, crafters, educators, hobbyists, engineers, science clubs, artists, students and commercial exhibitors. At this two-day faire, Maker exhibits are woven throughout Balboa Park grounds and into participating museums. The participatory model brings new visitors to the Park, provides exposure for museums, and invites a myriad of sponsorship opportunities. OTHER PROGRAM SERVICES 6: Community Engagement (Community and Military Access Passes):Balboa Park Explorer gives back to the community through the Community Access Pass (CAP) program, which provides the opportunity for underserved families, and now active duty military families, to experience the cultural and educational joys of Balboa Park. The CAP program partners with local nonprofits to distribute free annual Balboa Park Explorer passes to economically disadvantaged, at-risk, and traditionally underserved families. Established in 2017, the Military Appreciation Pass (MAP) program provides the same family passes to active duty military families living in San Diego County. Sixteen participating BPCP member organizations provide free admission to pass recipients. OTHER PROGRAM SERVICES 7: Parkwide Communications:Improving marketing efforts and positioning Balboa Park as a must-visit destination are the goals for Parkwide Communications. Developing data streams to inform marketing decisions, assisting member organizations with positioning and communications strategies, and leveraging the exhibitions, events, and activities happening park-wide for promotional efforts combine to elevate the public perception of the park and increase desire for visitation, including extended day visits with multiple experiences, and repeat visits.</p>
