THE FOUNDATION HAS MET THE PUBLIC SUPPORT TEST IN PRIOR YEARS AND EXPECTS TO DO SO AGAIN AS IT REVISES ITS DONOR STRATEGY IN SUPPORT OF CURRENT PROGRAMMING PRIORITIES. WHILE WE ARE CERTAIN OF THE PUBLIC NATURE OF OUR WORK AT THE FOUNDATION, WE WISH TO PROVIDE ADDITIONAL INFORMATION TO UNDERSCORE OUR COMMITMENT TO MEETING THE PUBLIC SUPPORT TEST UNDER IRS GUIDELINES. THE PUBLIC SUPPORT TEST IS IMPACTED BY MAJOR ACTIVITIES THAT OCCURRED DURING THE 5-YEAR LOOKBACK PERIOD. IN LATE 2019, THE FOUNDATION UNDERWENT A SIGNIFICANT TRANSITION, FOLLOWED BY THE IMPACTS OF THE COVID-19 PANDEMIC WHICH FORCED IT TO SUSPEND SOME PROGRAMMING. THE FOUNDATION RECEIVED SEVERAL MAJOR GRANT TO HELP SUPPORT ITS ACTIVITIES DURING THIS TIME, THE EFFECTS OF WHICH IMPACT THE CALCULATIONS. SINCE THAT TIME, THE FOUNDATION HAS WORKED SUCCESSFULLY TO ATTRACT MORE DONORS AND NEW CONTRIBUTORS AND EXPECTS TO CONTINUE TO GROW ITS DONOR BASE. THE FOUNDATION'S MAJOR ACTIVITIES BENEFIT THE GENERAL PUBLIC, PARTICULARLY ARIZONA RESIDENTS. DURING THIS TAX YEAR, ACTIVITIES INCLUDED: PUBLICATIONS AND WHITE PAPERS, INCLUDING A PUBLIC EDUCATION SERIES ON GROUNDWATER MANAGEMENT IN ARIZONA LEADERSHIP DEVELOPMENT VIA THE ARIZONA JUNIOR FELLOWS, A PROGRAM TO GIVE COLLEGE STUDENTS EXPERIENCE IN PUBLIC POLICY AND CIVIC LEADERSHIP. OVER THE COURSE OF THE ACADEMIC YEAR, THE FELLOWS PRODUCED TWO ON-CAMPUS EVENTS AS PART OF ITS SERIES, THE FUTURE OF ARIZONA DEMOCRACY, WHICH ARE OPEN TO THE PUBLIC AND INTENDED TO FACILITATE CIVIC DISCOURSE. REGULAR PUBLICATION OF CHAMBER BUSINESS NEWS, WHICH SHARES NONPARTISAN PUBLIC AFFAIRS CONTENT AND ORIGINAL REPORTING WITH THE STATEWIDE BUSINESS COMMUNITY AND THE GENERAL PUBLIC. WE BELIEVE THESE FACTS AND CIRCUMSTANCES MEET AND SUPPORT THE PROPER CLASSIFICATION OF THE ARIZONA CHAMBER FOUNDATION AS A PUBLIC CHARITABLE ORGANIZATION. BASED ON MANAGEMENT'S PROJECTIONS, WE ANTICIPATE THE PUBLIC SUPPORT PERCENTAGE WILL INCREASE TO 33.76% FOR 2022-2023 AND 55.67% FOR 2023-2024 FROM NON-GOVERNMENT SOURCES. FOR 2022-2023 THE FOUNDATION WAS AWARDED \$5.8 MILLION IN STATE AND LOCAL FISCAL RECOVERY FUNDS OF THE AMERICAN RESCUE PLAN ACT TO SUPPORT PANDEMIC RELIEF AND RECOVERY PROJECTS.
