WE OPERATE IN AN ECONOMY WHERE IT'S TYPICAL FOR SOMEONE TO EARN 2 PER DAY IF THEY EVEN HAVE EMPLOYMENT. WE PROVIDE SMALL GRANTS TO COLLECTIVES OF WOMEN WITH DRIVE AND DREAMS TO ENABLE THEM TO START, IMPROVE OR EXPAND MICROBUSINESSES. THE WOMEN WE SERVE HAVE NO OTHER ACCESS TO CAPITAL. WE ALSO OPERATE TWO SEWING TRADE SCHOOLS IN PARTNERSHIP WITH ANOTHER NONPROFIT, CONGO CHILDREN TRUST, AT WHICH WE TRAIN WOMEN IN SEWING AND BASIC BUSINESS SKILLS TO GIVE THEM A LIVELIHOOD. ADDITIONALLY WE OPERATE A HAIR DRESSER TRAINING PROGRAM.
