THE EXECUTIVE DIRECTOR MONITORS ONGOING TRANSACTIONS FOR CONFLICT OF INTEREST VIOLATIONS THROUGH NORMAL REVIEW OF MONTHLY PURCHASES AND INVOICE PAYMENTS. THE BOARD OF DIRECTORS PROVIDES OVERSIGHT AND GIVES FEEDBACK TO THE EXECUTIVE DIRECTOR FOR POTENTIAL CONFLICT OF INTEREST ISSUES DETERMINED WHEN APPROVING PURCHASES AND INVOICES THAT REQUIRE THEIR SIGNATURE. THE KEY EMPLOYEES COVERED BY THE POLICY ARE THE EXECUTIVE DIRECTOR, MANAGING ATTORNEY, AND FISCAL PERSONNEL. THE LEVEL OF DETERMINATION THAT A CONFLICT OF INTEREST IS MADE AND REVIEWED IS AT THE EXECUTIVE DIRECTOR'S AND BOARD OF DIRECTORS' LEVELS. THE ORGANIZATION USES THE PERSONNEL POLICIES FOR DISCIPLINARY ACTION AND TERMINATION AS A GUIDELINE FOR PERSONS WITH A CONFLICT. THE BOARD OF DIRECTORS HAS A CONFLICT OF INTEREST POLICY. ANNUALLY, THE REPORT IS GIVEN TO EACH BOARD MEMBER TO COMPLETE AND FORWARD TO THE PROGRAM.
