A PORTION OF OUR ASSISTANCE GOES BEYOND FINANCIAL AND INVOLVES ACTUAL SURGERIES, TRAINING, EDUCATION, AND EQUIPMENT SUPPLIED TO COMMUNITIES WHO OTHERWISE WOULD NOT HAVE THIS AVAILABLE TO THEM.
