ELECTIVE SURGERIES RESUMED DURING THE MONTH OF MAY 2020. THE COVID-19 PANDEMIC REQUIRED AN UNPRECEDENTED MOBILIZATION EFFORT ON THE PART OF HA IN ORDER TO APPROPRIATELY CARE FOR COVID-19 PATIENTS WHILE SIMULTANEOUSLY ENSURING THE SAFETY AND WELL-BEING OF ITS STAFF. THIS EFFORT CUT ACROSS VIRTUALLY ALL DEPARTMENTS AND DISCIPLINES. THIS ENABLED A SIGNIFICANTLY HIGH LEVEL OF OPERATIONAL AND CLINICAL COORDINATION THAT ALLOWED HA TO ACHIEVE MEANINGFUL ACCESS AND HIGH QUALITY CLINICAL OUTCOMES FOR ITS PATIENTS. THE PROCESSES AND PROCEDURES IMPLEMENTED FOR COVID-19 PROVIDED FOR ADEQUATE SUPPLIES OF PERSONAL PROTECTIVE EQUIPMENT ("PPE") FOR ALL CLINICAL AND NON-CLINICAL STAFF. MARCH 28, 2020 GOVERNOR ANDREW CUOMO OF NEW YORK ANNOUNCED HA HAS BEEN SELECTED TO BE ONE OF THE SELECT HOSPITALS IN THE STATE TO BE A TEMPORARY CARE CENTER FOR PATIENTS. IN RESPONSE, ALL SERVICES WERE MOVED OUT OF THE MARY'S AVENUE CAMPUS, TRANSFERRING TO THE BROADWAY CAMPUS AND OTHER NETWORK FACILITIES. THE MARY'S AVENUE CAMPUS WAS TRANSFORMED INTO A COVID CARE HOSPITAL IN ANTICIPATION OF AN INFLUX OF COVID PATIENTS THROUGHOUT NORTHEASTERN NEW YORK. AT THE ONSET OF THE PANDEMIC, NON-ESSENTIAL STAFF WERE SETUP TO WORK FROM HOME AND ACCOMMODATIONS WERE MADE FOR STAFF TO FLEX THEIR TIME BETWEEN HOME AND BEING IN THE OFFICE AS NEEDED. ADDITIONAL MANPOWER WAS EMPLOYED TO HELP IN ESSENTIAL AREAS. AS CASES BEGAN IN THE REGION, HA MADE GRADUAL CHANGES TO VISITATION POLICIES, ULTIMATELY RESULTING IN NO VISITORS ON SITE, EXCEPT PEDIATRICS AND END-OF-LIFE CIRCUMSTANCES. FOLLOWING THAT HA BEGAN TO RESCHEDULE ELECTIVE SURGICAL PROCEDURES AND PROVIDED PATIENTS OF THE OUTPATIENT MEDICAL OFFICES THE ABILITY TO SHIFT TO VIRTUAL VISITS. WHILE DOING THIS, HA INCREASED BED CAPACITY. IN ADDITION TO THE INCREASE IN BED CAPACITY, STAFF ADJUSTMENTS INCLUDED THE DEPLOYMENT OF WORK FROM HOME PROCESSES FOR APPROPRIATE NON-CLINICAL, NON-ESSENTIAL STAFF. NON-CLINICAL, NON-ESSENTIAL STAFF WHO COULD NOT WORK FROM HOME WERE REDEPLOYED TO ASSIST IN OTHER AREAS OF THE FACILITIES. THROUGHOUT THE PANDEMIC SURGE, HA FLEXED ORGANIZATION OPERATIONS AND STAFFING TO MEET THE DEMANDS AND NEEDS OF ITS COMMUNITY AND PATIENTS.</p>
