Despite the challenges created by the COVID pandemic, the Napa Valley Vine Trail Coalition was able to make strides towards its mission. 1. Surviving COVIDNVVTC adapted an austerity budget in June 2020. This included voluntary staff salary and payroll reductions and rent reductions negotiated with our landlord.NVVTC secured \$255,000 in federal funds in 2020/2021. Two Payroll Protection Program loans totaling over \$89,000 were forgiven. Repayment of loan from the Maintenance FundThe austerity budget adopted by the Board in June 2020 relied on borrowing \$350,000 from the Maintenance Fund. The final \$202,297 in borrowed funds were repaid in July 2021. 3. Rights of Way Secured for St Helena to Calistoga Section.In December 2020, the Vine Trail successfully negotiated with fourteen property owners to secure the easements necessary to construct the Vine Trail between St. Helena and Calistoga. The Vine Trail acquired the easements for a cost of \$800,000 and an additional \$100,000 for legal costs. The source of funding for the easements is a \$1 million line of credit. 4. Grant FundingNVVTC assisted Napa County in applying for \$10 million for the Yountville to St. Helena segment of the Vine Trail under the state's Active Transportation Program in 2020. Although this application was not successful, useful lessons were learned in how to position this rural section of the Vine Trail.Despite the challenges of COVID and working remotely with consultants and partner agencies, NVVTC was able to apply for and secure three competitive grants totaling \$814,000 for the Vallejo section of the Vine Trail. These funds will be administered by the Solano Transportation Authority and City of Vallejo. - \$414,000 Urban Greening Grant for the Enterprise Street section of the Vine Trail/Bay Trail. - \$400,000 Bay Trail Grant for project under their under served communities program.5. Twenty-mile Milestone met by June 2021Two new, short sections of the Vine Trail were completed by our public agency partners in 2020/2021 bringing 20.16 miles of the 47 miles into use. 6. The Vintner CollectionThis five-year fundraising program, partnering with ten premiere wineries in Napa Valley, got off to a great start raising more than \$350,000. 7. Closing the St. Helena GapThe Vine Trail Coalition held the first public meeting on the Vine Trails downtown St. Helena connector. This study is being prepared by BFK Engineering. The Vine Trail is splitting the cost with the City of St. Helena. The draft study was completed in October 2020 and presented to the Vine Trail Engineering Committee and to the St. Helena Active Transportation and Sustainability Committee. Although it is anticipated that there will be further public meetings into 2021/222, the study has started to move the process forward.8. Vine Trail Use SurgesThe biggest reward this year was the surge in Vine Trail use. With gyms and playgrounds closed due to COVID-19, many families turned to using the Vine Trail for exercise. During 2020, there were 522,933 uses of the Vine Trail, a 46% increase over 2019.9. Fundraising: LOCO-MOTION and Month of MovementThe inaugural Month of Movement raised \$138,000. The LOCO-MOTION special event with online auction, fund-a-need, sponsorships, and dinner tickets was also a success, grossing over \$271,000.10. Increased Social ConnectionsOur connections through social media and emailed newsletters grew during 2020/2021.Facebook fans increased by 29%, Instagram followers increased by 11% and the newsletter subscriptions increased by 51%.
