Under generally accepted accounting practices GAAP, the entire amount of the grant was recognized. However, during the year, the Organization was awarded grants from several first-time donors. The Organization maintains its public charity status under the facts and circumstances test because its public support is more than 10 of its total support. The Organization remains cognizant of its need to continue to attract future support from a more diverse group of donors.
