Ruby's Pantry: The Organization runs a food distribution program that distributes donated corporate surplus food through over 80 church-sponsored distribution sites in the Midwest. In 2022, there were 216,098 families served in these distributions; 18,674,250 pounds of food received from donors. As is our practice, \$517,186 was donated to sponsoring churches to be used for benevolence and other expenses.

Ruby's Second Hand: The Organization operates a thrift store in Siren, WI that provides donated clothing and other items at low prices. It also has a program where teachers from the local school district that the Organization serves can send home a list for students in need of clothing, and Ruby's Second Hand will fill the order without cost.

Ruby's Luck: Housed in a 40,000 square-foot, former-nursing home, the Center is being used to provide lodging and medical services to residents in Polk and Burnett counties in Wisconsin, which are very underserved and surrounded in poverty.
