In 2020 Praying Pelican Missions PPM facilitate in excess of 1700 short-term missionaries throughout eleven countries one US Territory and ten United States locations. These participants assisted in hurricane recovery and relief homeless care ministries children's ministries community outreach sports programs and many other ministries alongside local community partners. As a part of hosting these missionary participants PPM facilitated all trip logistics including arranging meals lodging and transportation for each team. Note: Domestic teams serving in the lower 48 states generally arranged their own transportation to ministry sites. PPM staff was also assigned to lead each group spending between six and twelve months preparing for each trip through phone and in-person consultations. Significant time and resources were also invested in preparing for these teams through networking and investing in trusted host partners and ministries in each location. When the COVID-19 pandemic set in during March 2020 PPM temporarily paused mission trips as required by local state and federal mandates as well as international location travel restrictions. The pandemic and associated gathering and travel restrictions had a significant effect on program services. During these restriction periods PPM staff focused their efforts on building up encouraging and assisting local churches in navigating the pandemic challenges as best they could. PPM developed a comprehensive COVID safety program and industry-leading protocols to meet CDC and local government safety standards in order to quickly return to the mission field where our staff and our mission teams could continue serving their communities.
