CORKTOWN APPROACHED THE FUND AFTER THEIR PATIENTS REPEATEDLY ASKED FOR THEM TO PROVIDE AFFIRMING, NONJUDGMENTAL DENTAL CARE DESIGNED FOR THIS POPULATION. THE FUND NOT ONLY FUNDED ALL OF THE EQUIPMENT FOR THEIR FUTURE DENTAL CLINIC, THE FUND ALSO CONNECTED CORKTOWN TO A RESEARCHER AT INDIANA UNIVERSITY SCHOOL OF DENTISTRY (IUSD). TOGETHER, CORKTOWN AND IUSD DEVELOPED A DENTIST AND PATIENT SURVEY ABOUT ATTITUDES AND TREATMENT OF THE LGBTQ+ POPULATION, WHICH WAS SUBSEQUENTLY ADMINISTERED IN MICHIGAN AND INDIANA. THE GOAL IS TO USE SURVEY RESULTS TO DEVELOP EDUCATION FOR DENTAL PROFESSIONALS AND STUDENTS AND REDUCE BARRIERS TO CARE. THIS PROGRAM USES PARTNER RESOURCES AND COMPREHENSIVE, INTEGRATED CARE TO HELP PEOPLE EXPERIENCING HOMELESSNESS. APPROXIMATELY 2,000 PATIENTS WILL BE SERVED EVERY YEAR.
