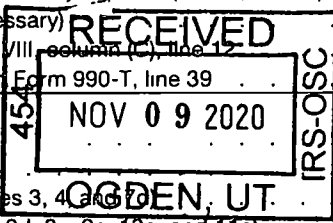

Northland Lutheran Services for the Elderly, Inc. mission is to meet the spiritual, physical, emotional, social needs of those being served.

Luther Home, a skilled nursing and rehabilitation facility admitted 234 and discharged 241 individuals in 2019. Of the total discharges, 168 were discharged to home and 9 to Luther Manor. Average occupancy in 2019 was 87.2 percent. Luther Home's medicaid write-off in 2019 was \$1,760,547.

4b (Code:) (Expenses \$ 1,118,210 including grants of \$) (Revenue \$ 1,349,650)

Luther Manor provides assisted living arrangements to persons needing services, but who do not need full nursing care. Supportive services include dietary, housekeeping, laundry, medication management along with social and spiritual needs in an environment that is dedicated to quality of life. Physical therapy provides exercise programs for residents.

Lifeline is a community outreach service program provided by Northland Lutheran Services for the Elderly, Inc. It is an emergency response system that helps individuals by staying independent in their own home environment.
