THE ORGANIZATION ACCOMPANIED 14 VICTIMS TO THE HOSPITAL, AS WELL AS ADVOCACY AT THE CHIPPEWA VALLEY CHILD ADVOCACY CENTER FOR 16 MINORS WHO WERE SEXUAL ASSAULT VICTIMS.
