Savers stores are also equipped to receive donations of used goods that are dropped off by the general public; those goods are received on behalf of EFMN and sold "on the spot" by EFMN to Savers, Inc. EFMN does not incur any fundraising expense and thus Schedule G-I is not invoked. No payment is made by EFMN to Savers; Savers' right to purchase used goods is required by the parties agreement. The agreement's transactional results are reported on Part VIII, lines 10a-c. EFMN does comply with the reporting requirements for professional fundraisers.
