The treatment center staff also works with campers to help them understand their disorder and to be able to explain their disorder to others. Qualified counselors and volunteers, many of whom have a bleeding disorder undergo training and education on issues related to bleeding disorders. In addition, there is a staff of medical professionals onsite to ensure safety and assist with medical needs.
