The selection of students for attendance at Our Lady of Mercy or Bishop Kearney High Schools:

Rochester Refugee Resettlement Services has inherited a scholarship program that was begun by Kathy LaBue when she was director (and Founder) of Mary's Place Refugee Outreach. At that time, Mary's Place was a program of the Cathedral Community of the Roman Catholic Diocese of Rochester. When Kathy retired as director of Mary's Place she brought the program with her, as it

did not fit in to the program and budget of the new management.

Conceptually, the scholarship fund has been centered on refugee families who could not afford to pay the tuition but whose children would clearly benefit from a quality Catholic education and the families could not afford the tuition. Many of these students are coming from Holy Cross Catholic elementary school. Holy Cross has taken these students and has not required us to supplement tuition. It has been a natural progression, therefore, for these students to progress to Bishop Kearney or Mercy. The selection of who attends is further controlled by the schools themselves. Kathy has submitted the names of many more students than those selected.
