IEP USA has had a successful year, continuing to expand the profile of the organization and our programming, including: Mexico ProgramThe Mexico Office had a strong start to this financial year with the signing of two new Positive Peace Training projects with Rotary and the Mexican State of Jalisco. An ongoing collaboration with the state of Hidalgo will be drawing to a close at the end of the calendar year. IEPs profile has continued to expand in the country and partnership talks with other Mexican states and government departments are progressing well. The Mexico Director has managed the program very well in difficult circumstances and has been given additional responsibilities this year, including oversight of IEP Activities in Peru, Ecuador and Venezuela. RotaryThe partnership continues to evolve. A number of US based Activators have expressed interest in extending their two-year commitment, which ends in 2022. Latin American Activators are halfway through their term. In total, Activators in the region have undertaken 226 presentations, trainings and strategic conversations, reaching over 50,000 people. The Activator Program is currently being expanded into Europe and Asia, led by IEP Offices and staff in or close to those regions. Positive PeaceSince last year IEP has signed MOU with World Vision International (WVI), whom are interested in formally adopting Positive Peace as their main peacebuilding framework. Exploratory training sessions with WVI staff have been held in the Democratic Republic of Congo and Iraq. Positive Peace workshops for RfP staff have been completed (virtually) in Latin America and trainings with the staff in Africa is due to get underway soon. Exploratory conversations have been held with the Peace Corps, and workshops and trainings (virtual) have been given to various organizations throughout the year, mostly in Latin America. A noteworthy partnership has been struck with NewGen Builders, who has integrated Positive Peace into educational curricula that will be used by students in 120 US High Schools this year. Global Peace IndexThe 15th edition of the Global Peace Index was released in June 2021. The US launch event was well attended and held in partnership with IPI. Follow-up launch events were held for a number of US and internationally based organizations including USAID, NATO Association, DME For Peace and Trust Network as well as many others including US Congressional Staff. Virtual GPI Launch events were held in Ecuador, Mexico, Peru and Colombia. Ecological Threat ReportThe second edition of this report was launched just before COP and has been very well received. The Launch event was held in partnership with The Global Alliance for a Sustainable Planet. This was followed by public events with Alliance for Peacebuilding, the Stimson Center and the International Chamber of Commerce among others. Key Staff briefings have been completed for World Vision, Pact Inc and USAID and presentations in Mexico are currently underway. OutreachAlthough travel has been limited over the past year due to the ongoing impact of the Coronavirus Pandemic, our offices have been able to maintain an active public speaking and event calendar, albeit largely virtual. US and Mexico office staff have spoken at over 130 events this year, covering the width and length of the Americas region. New contacts and networks have been established in Argentina, Peru, Ecuador and Colombia. IEP has invested significant time in the latter recently, having noted a deep interest in Positive Peace on behalf of civil society but also local government. A number of conversations are currently underway.
