Develop a non-breeding Spanish Mustang Preservation Program to educate on the historical significance of the original Spanish Mustang. Offer on-site therapy and education, connecting adults and children with the horses, while discussing problems, identifying solutions and demonstrating ways the public can help make a difference. Host natural horsemanship training programs related to wild horse handling, management and care, facilitating successful adoptions. Utilize our trained ranch Mustangs as an example of their potential and versatility for work, pleasure and show. Serve as a practical model for sustainable herd, pasture and land management- working with the BLM and specific HMAs to arrive at a viable solution for the future of the wild horses. Offer an eco-sanctuary environment where people can connect with the horses, with nature and with themselves. Serve as a model for sustainable build.
