Youth Ambassadors empowers underserved teens, ages 14-18, most of whom have a history of multiple trauma exposure and continue to live in compromising circumstances. Unabated intergenerational poverty, single-parent households, the continuation of blighted infrastructures, as well as high unemployment, underemployment, transiency and teenage incarceration rates are among the myriad of problems our youth face. Youth Ambassadors educates up to 300 youth annually through summer and academic year programming. Youth Ambassadors teaches self-efficacy through programs during non-school hours when youth are most susceptible to negative influences. Through creative programming, Ambassadors gain the necessary tools needed to continue their education and/or enter the job market successfully. The Youth Ambassadors program is also designed to provide a "first job" experience. Through the receipt of a paycheck, Ambassadors learn banking skills, and fiscal responsibility, workplace parameters, and personal accountability. Students in our program take the following classes daily; 21st Century Life and Job Skills, Health, Writing, and Art. The COVID-19 pandemic created unique challenges and opportunities over the last year. The week following Kansas City's stay-at-home orders in the spring, all Ambassadors were transitioned into virtual programming (primarily via Zoom, Google Classroom and Moodle), which continued through the summer and into the 2020-21 school year. Upon this transition, the staff quickly realized some youth reside in homes with limited access to technology, food, or other resources. Therefore, Youth Ambassadors engaged its board of directors, staff, and community partners to provide youth with the resources and forms of social connectivity needed to feel supported during this pandemic. Examples include contact-free door-to-door fresh food delivery (in collaboration with Kanbe's Markets), distribution of technology (laptops and hotspots), and the offering of additional mental health services in the virtual setting. The program continued to operate virtually throughout 2020. With each virtual session, services and program implementation improve a little more each time. The core program components remain intact, but there have been minor changes due to the nature of virtual programming to provide some forms of social connectivity. For example, Youth Ambassadors began offering "Soul Circles" and "Mental Health Check-Ins" for youth, which consist of small groups or small activities to simply connect with staff and their peers on a deeper level. Additionally, art was temporarily removed from the virtual setting this school year, and instead, staff provided two optional in- person art activities for a small number of youth (i.e., a mini-art class with one of our instructors or a collaborative mural project, which was completed in October). As the landscape continues to change, Youth Ambassadors will remain flexible and ensure youth in Kansas City are offered robust programming, whether virtual or in-person, in a way that best meets the needs of the youth and community served.
