EXCEPT AS OTHERWISE PROVIDED IN THESE BY-LAWS, THE VOTE OF THE MEMBERS HOLDING A MAJORITY OF THE VOTING POWER PRESENT AND ENTITLED TO VOTE AT A MEETING WITH A QUORUM PRESENT SHALL CONSTITUTE THE ACT OF THE MEMBERSHIP OF THE CLUB. CUMULATIVE VOTING SHALL NOT BE ALLOWED IN THE ELECTION OF DIRECTORS.
