THE CONSORTIUM MEMBERS SHALL EXERCISE THEIR CONSORTIUM MEMBERSHIP RIGHTS AND WHERE APPROPRIATE MAY EXERCISE THEIR VOTE ON ANY MATTER TO COME BEFORE SUCH CLASS OF CONSORTIUM MEMBERS BY PRESENTMENT OF A WRITTEN ACTION SIGNED BY AN AUTHORIZED OFFICER OF SUCH CONSORTIUM MEMBER, AND THE CORPORATION SHALL BE ENTITLED TO RELY UPON SUCH WRITTEN ACTION. THE ACTION BY A CLASS OF CONSORTIUM MEMBERS SHALL REQUIRE THE AFFIRMATIVE VOTE OF A MAJORITY OF ITS MEMBERS.
