Our work ensured that the voice of the American people - 80 percent of whom oppose slaughter and want wild horses and burros protected on our public lands -- was heard by Congress and government policy makers

Legal Precedents for Protection Litigation Our expert legal team continued to accumulate precedent setting wins in 2017, including an Idaho lower court decision affirming the Bureau of Land Managements (BLMs) legal mandate to manage wild horse in self sustaining herds and protect their natural behaviors. We also scored two appellate court victories. The Ninth Circuit granted our motion to dismiss a livestock industry lawsuit seeking the roundup and slaughter of thousands of wild horses and burros, while the DC Circuit vacated a U S Forest Service decision to shrink the size of Californias largest and most significant Wild Horse Territory. Our legal efforts provided a critical defense for wild horses and burros in the West against efforts by the government and special interests to destroy these iconic animals and reduce their habitat.
