Driving Change Through Awareness and Empowerment Advocacy/Education AWHC is the leading voice for wild horse and burro protection in America. In 2018, we were mentioned and/or featured in 117 media reports this year, including major stories on ABC News, NBC News, and CBS News. Our high profile public awareness campaign over a U.S. Forest Service decision to sell California wild horses for slaughter generated international media attention and statements of opposition from California's top lawmakers. We also continued to empower our supporters to speak up by creating easy-to-use action alerts to weigh in on policy matters affecting wild horses and burros, generating 210,000 public comments and 600,000 petition signatures on key policy issues.

Form 990, Part III, Line 4b:

Supporting Communities, Saving Local Herds (Field programs) We work closely with our local coalition partners in key areas of the West to protect and humanely manage local herds and our strategic, technical and financial support has allowed communities to preserve and protect numerous wild horse herds, including the Salt River wild horses in Arizona and the Fish Springs and Virginia Range wild horses in Nevada. In Arizona, we sponsored the Salt River horse PZP fertility control program, which uses the PZP vaccine, delivered via remote darting to wild mare to humanely reduce population growth rates and herd size over time. We sponsored the required certification class for darters and purchased the vaccine by training and equipping darters and purchasing the vaccine necessary for year 1 of the successful program. In Nevada, we worked with the business community create year-round water sources for wild horses at the Tahoe Reno Industrial Center, and we provided support to the local community in Gardnerville, Nevada to rally to save a cherished local herd from a BLM roundup plan.

Form 990, Part III, Line 4c:

Saving Lives (Rescue) While the primary focus of AWHC's work is keeping wild horses wild, we are called upon to help horses and burros who are no longer free. In 2018, AWHC provided direct assistance to help hundreds of wild horses in need by financially supporting the rescue of dozens of wild mustangs from slaughter, rescuing five Virginia Range horses from a kill pen in Alabama, and providing funding to purchase hay to keep 100+ Virginia Range horses on the range and feed 150+ wild horses in a sanctuary experiencing serious financial problems.

Providing Accountability - (Roundup Observation, Conferences/Meetings/Field Tours) America's wild horses exist in remote areas of the west, out of the view of the majority of Americans. As a result, inhumane wild horse roundups often go unseen. AWHC is committed to providing transparency to this federal program and its front line actions. The AWHC documented nearly every helicopter roundup that took place in 2019. Our observers' powerful images and video of foals being stampeded to the point of exhaustion, horses crashing into barbed wire, and horses crashing into and over the panels of the trap pens were featured on national television news programs and in newspapers across the country. Through this work, we educated millions of citizens about the plight of America's wild horses and burros and the urgent need to reform the government management program. We also filed numerous complaints against the BLM for violations of animal welfare standards, and attended the majority of key public events and tours conducted by the BLM to bring the voice of the people to the agency and to challenge agency officials on inhumane and wasteful management practices.
