IN 2017 WE FOCUSED ON PROGRAMS THAT MET THE GOALS OF OUR STRATEGIC PLAN. WE FOCUSED ON DEVELOPING SOCIAL, EDUCATIONAL, AND WELLNESS PROGRAMS ALONG SPECIFIC CRITERIA TO HELP UNITE SEXUAL & GENDER MINORITIES (SGM) AND COLLABORATE WITH PARTNERS. WE ALSO CONTINUED TO ENHANCE AND DEVELOP PROGRAMS THAT SERVE THE DISENFRANCHISED PARTS OF SGM.
