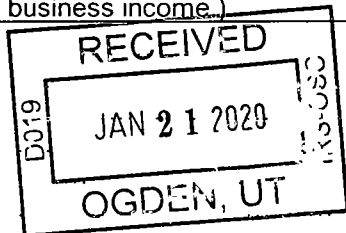

Federal Statements

Statement 1 - Form 990-T - Explanation for Amending

Description

The taxpayer is amending Form 990-T as a result of the President signing P.L. 116-94. The law repealed Internal Revenue Code Section 512(a)(7) which originally required tax-exempt organizations to include in unrelated business taxable income the amount of qualified transportation fringes. IRC Section 512(a)(7) was first effective for tax years after December 31, 2017. P.L. 116-94 repealed Internal Revenue Code Section 512(a)(7) as if the provision was never enacted. The amendment is a request to refund the amount of tax paid on the 2018 originally filed return.
