Legal Assistance - The Legal Clinic through staff attorneys as well as volunteer lawyers and paralegals provided low-barrier, high quality, pro bono legal help for people experiencing homelessness and housing insecurity. In 2019, we conducted 234 community intake sessions where our volunteer attorneys met with more than 445 clients. Our staff attorneys assisted an additional 278 clients. Overall, 160 cases were related to shelter issues (a number of which focused on securing access to shelter for families who had been unlawfully denied admission to this life-saving resource), 128 cases involved housing issues (often related to short- and long-term housing subsidies), and 116 involved cash benefits (including disability benefits and SNAP). The remainder was a mix of civil issues that included consumer matters, discrimination, disability rights, police conduct, identification and more. In addition, the Legal Clinic leveraged \$2.9 million in pro-bono legal services from DC law firms and lawyers to provide services to clients through our Legal Assistance Project.

Affordable Housing Initiative - The overarching goal of our housing initiative is to prevent displacement and homelessness by protecting the housing of low income renters from the forces of redevelopment, deteriorating conditions, or loss of subsidy. Our approach is to provide traditional legal assistance, leverage pro bono, and engage community leaders and media to achieve clients' objectives. In 2019, we continued our work with residents of Brookland Manor and Congress Heights to help them remain in their communities as redevelopment happens around them. In the Brookland Manor case, we had oral argument before the DC Court of Appeals on our appeal of the adverse Zoning Commission decision. We await a decision from the court. In the Congress Heights case, we continued to work with residents to preserve not only their ability to remain in their community, but to secure the development of 200 affordable units on the property, as well. In addition, the Legal Clinic leveraged over \$2.8 million in pro-bono legal services from DC law firms and lawyers to protect the rights of tenants.

Homeless Services Advocacy - The Legal Clinic worked to improve access to shelter for families and for people with disabilities, and to ensure the safety and quality of the homeless services system. Strategies included budget and policy advocacy, client training, education and support, and administrative/agency advocacy. In addition, the Legal Clinic leveraged \$91,000 in pro-bono legal services to assist families who were wrongly denied access to shelter and to support other efforts to improve the shelter system.

In general, the Executive Director works with the President to develop recommendations for increasing salary levels. In developing recommendations, the Executive Director reviews information about salaries at other similar organizations, as well as in the government. The President and the Executive Director then present the salary recommendations to the Finance Committee as part of the proposed budget. The Finance Committee then recommends approval of the budget to the full Board of Directors. The full Board of Directors approve the full budget, including salary adjustments, at its annual meeting. No salary adjustments were approved in 2019. Small bonuses are generally, but not always, given towards the end of December. The Executive Director gets the Board of Directors' approval and then informs the Administrator to provide a bonus payroll. The most recent compensation study was conducted in 2017.</p>
