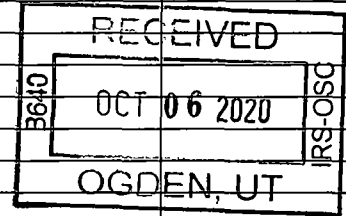



REASON FOR AMENDED RETURN:

INTERNAL REVENUE CODE SECTION 512(A)(7) HAS BEEN REPEALED TO ELIMINATE THE TAX ON QUALIFIED TRANSPORTATION FRINGE BENEFITS.

PART I: LINES 12 & 13 REDUCED FROM \$52,125 TO ZERO AS A RESULT OF THE REMOVAL OF THE QUALIFIED TRANSPORTATION FRINGE AMOUNT.

PART II: LINES 30, 32 & 34 TO REFLECT THE DECREASE IN INCOME.

PART III: LINES 35C & 40 INCOME TAX IS REDUCED FROM \$9,991 TO ZERO AS A RESULT OF THE DECREASE IN INCOME.
