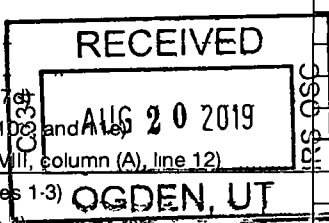

**THE FOUNDATION PROVIDES LEGAL ASSISTANCE TO WORKERS SUFFERING FROM ABUSES OF COMPULSORY UNIONISM IN HUNDREDS OF CASES NATIONWIDE. DURING 2018, FOUNDATION STAFF ATTORNEYS HANDLED 279 CASES, REPRESENTED 525 CLIENTS, AND REPRESENTED THE INTERESTS OF OVER 34,000 CLASS MEMBERS IN TWO CERTIFIED CLASS ACTION CASES. ON JUNE 27, 2018, FOUNDATION STAFF ATTORNEYS WON A MAJOR VICTORY IN THE U.S. SUPREME COURT, JANUS V. AFSCME. THE COURT OVERRULED ITS 1977 ABOOD DECISION AND DECLARED MANDATORY PUBLIC-SECTOR AGENCY FEES UNCONSTITUTIONAL UNDER THE FIRST AMENDMENT.
