WE HAVE BEEN ABLE TO DIVERSIFY OUR STUDENT POPULATION AS A RESULT OF MINORITY SCHOLARSHIP THAT WAS ESTABLISHED IN 2003. FOR THE 2018-2019 SCHOOL YEAR, WE HAD 14 MINORITY FAMILIES, 9 OF WHICH APPLIED FOR AND WERE AWARDED THE MINORITY SCHOLARSHIP. THE SCHOLARSHIPS FOR THESE 9 FAMILIES ENCOMPASSED 12 STUDENTS.
