THROUGH THIS PROGRAM, EQUALITY CALIFORNIA INSTITUTE CONTACTED MORE THAN 200,000 LGBTQ+ AND ALLIED CALIFORNIANS ABOUT THE IMPORTANCE OF CENSUS PARTICIPATION AND COLLECTED APPROXIMATELY 5,500 PLEDGES TO COMPLETE THE 2020 CENSUS. EQUALITY CALIFORNIA INSTITUTE ALSO RECRUITED 22 LOCAL LGBTQ+ ORGANIZATIONS THROUGHOUT THE STATE TO SUPPORT CENSUS OUTREACH AND EDUCATION EFFORTS. WITH THE SUPPORT OF SILVER STATE VOICES, EQUALITY CALIFORNIA INSTITUTE'S NEVADA-BASED PROGRAM, SILVER STATE EQUALITY INSTITUTE, ALSO CONDUCTED LGBTQ+ TARGETED CENSUS OUTREACH AND "GET OUT THE VOTE" EFFORTS IN NEVADA, THROUGH DIGITAL MEDIA CAMPAIGNS THAT RECEIVED MILLIONS OF IMPRESSIONS AND TENS OF THOUSANDS OF ENGAGEMENT POINTS.

THE TRAINING PROMOTES LGBTQ+ INCLUSION AND OFFERS PRACTITIONERS A RANGE OF TOOLS TO BETTER IDENTIFY AND SERVE THE NEEDS OF LGBTQ+ CLIENTS. EQUALITY CALIFORNIA INSTITUTE ALSO PARTNERED WITH THE CALIFORNIA LGBTQ+ HEALTH AND HUMAN SERVICES NETWORK AND NORCAL MENTAL HEALTH AMERICA TO CONCLUDE ITS MULTI-YEAR #OUT4MENTALHEALTH PUBLIC EDUCATION CAMPAIGN, A STATEWIDE COALITION-BACKED INITIATIVE AIMED AT REDUCING DISPARITIES IN LGBTQ+ MENTAL HEALTH. EQUALITY CALIFORNIA INSTITUTE CONTINUES TO MANAGE THE LOS ANGELES OUT AGAINST BIG TOBACCO COALITION AND ADDED A SECOND OUT AGAINST BIG TOBACCO COALITION IN THE CENTRAL VALLEY. BOTH PROGRAMS RAISE AWARENESS ABOUT TOBACCO USE DISPARITIES AMONG LGBTQ+ PEOPLE AND EDUCATE LAWMAKERS ON THE IMPORTANCE OF COMMON-SENSE TOBACCO-CONTROL POLICIES. EQUALITY CALIFORNIA INSTITUTE IS ALSO COMMITTED TO ENDING STIGMA AGAINST PEOPLE LIVING WITH HIV BY EDUCATING LEGISLATORS AND MOBILIZING THE LGBTQ+ COMMUNITY AND THOSE WHO ARE DISPROPORTIONATELY IMPACTED BY HIV.
