TO PROVIDE AFFORDABLE STUDENT HOUSING THAT FOSTERS THE IDEALS OF COOPERATION, COMMUNITY, AND ECONOMIC INDEPENDENCE." THE ORIGINAL COLLEGE HOUSE WAS FORMED IN 1964 AS A STUDENT GOVERNMENT PROJECT, WITH HELP FROM A \$5,000 SUSTAINING GRANT BY THE HOGG FOUNDATION. THE VISION BEHIND THE PROJECT WAS TO CREATE A HOUSING FACILITY FOR UNIVERSITY OF TEXAS (UT) STUDENTS THAT WAS AS VIBRANT AND STIMULATING AS THE DORMS OF A SMALL RESIDENTIAL COLLEGE. EACH SEMESTER, COLLEGE HOUSES PROVIDES HOUSING TO OVER 500 STUDENTS WHO ATTEND THE UNIVERSITY OF TEXAS AT AUSTIN, AUSTIN COMMUNITY COLLEGE, AND OTHER AREA SCHOOLS. ALL OF OUR HOUSING IS AFFORDABLE BELOW 50% MFI, WITH SOME DOUBLE-OCCUPANCY ROOMS AFFORDABLE BELOW 30% MFI. ACCORDING TO DATA FROM THE CITY OF AUSTIN, WE ARE ONE OF THE LARGEST PROVIDERS OF AFFORDABLE HOUSING IN THE UNIVERSITY OF TEXAS AREA. AS A COMMUNITY ORGANIZATION, COLLEGE HOUSES STRIVES TO ENCOURAGE DIVERSITY IN ITS MEMBERSHIP, AND TO PROVIDE ITS SERVICES TO THE STUDENTS WHO NEED THEM MOST. COLLEGE HOUSES CO-OPS ARE MORE THAN AN AFFORDABLE PLACE TO LIVE, EAT AND STUDY - OUR HOUSES ARE EDUCATIONAL COMMUNITIES.
