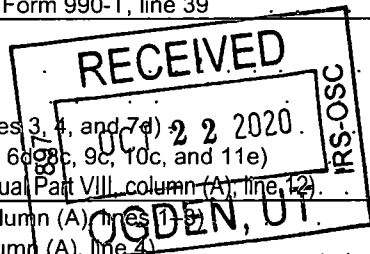

The program is supported by a BIPP grant and court appointed fees, expenditures include counseling fees and lease for office space
