THE CORPORATION'S MISSION IS TO ADDRESS THE DIAPER GAP AND ITS IMPACT ON INDIVIDUALS IN CRISIS. THE ORGANIZATION HAD MANY ENTITIES OR ORGANIZATIONS OR INDIVIDUALS CONTRIBUTE APPROXIMATELY \$5,600,000 OF NON-CASH ITEMS DURING 2022 THAT WAS DISTRIBUTED TO THE NEEDY. 213,500 INDIVIDUALS WERE IMPACTED.(IN ADDITION, TDB HAD OVER 4,500 VOLUNTEERS CONTRIBUTED WHICH HAS NOT BEEN REFLECTED IN THIS TAX RETURN.) A TOTAL OF 2.3 MILLION DIAPERS, 170,500 TAMPONS AND PADS, 156,000 ADULT DIAPERS AND 648,000 SUPPLEMENTAL GOODS WERE DISTRIBUTED IN 2022. 84 PARTNER AGENCIES AND 18 COUNTRIES WERE SERVED.
