Medical Services - The clinic operates under the license of a local, board certified OB/GYN in order to provide clients with health education and referrals tailored to specific needs. Each client has the opportunity to consult with an onsite registered nurse. Medical grade pregnancy tests are utilized to guide our services, and ultrasound exams are provided to verify a viable uterine pregnancy. A medical advisory team made up of local physicians and nurses meet at least twice per year to review medical services and policies. Annual donated services to the community are valued at 100,816. This program utilized a total of 1,038 volunteer hours, a value of approximately 100,816.
