4a (Code) (Expenses \$ 11,599,872 including grants of \$) (Revenue \$ 10,061,528) SANTA BARBARA NEIGHBORHOOD CLINICS (SBNC) IS COMPRISED OF FOUR PRIMARY CARE MEDICAL CLINICS, TWO DENTAL CLINICS HEALTH PROMOTION SERVICES AND PATIENT EDUCATION ARE PROVIDED WITHIN THE CLINICS AND THERE ARE BEHAVIORAL HEALTH SERVICES AVAILABLE AT THE GOLETA NEIGHBORHOOD CLINIC LOCATION THESE CLINICS ARE LOCATED IN THE CITIES OF SANTA BARBARA AND GOLETA AND IN ISLA VISTA, AN UNINCORPORATED DISTRICT AND CENSUS-DESIGNATED PLACE, IN THE COUNTY OF SANTA BARBARA, CALIFORNIA SBNC WAS FORMED IN 1998 THROUGH A MERGER OF THREE EXISTING MEDICAL CLINICS, WHICH HAD PROVIDED MEDICAL CARE TO THE UNDERSERVED POPULATIONS SINCE THE 1970'S SBNC PROVIDES A WIDE-SPECTRUM OF HEALTH CARE SERVICES AND HAS BEEN A SUB-RECIPIENT OF SANTA BARBARA COUNTY DEPARTMENT OF PUBLIC HEALTH SECTION 330 (H) HOMELESS GRANT SINCE 1998 IN 2013, SBNC WAS AWARDED A NEW ACCESS POINT DESIGNATION GRANT FROM THE HEALTH RESOURCES AND SERVICES ADMINISTRATION, DESIGNATING THE GOLETA EXPANSION SITE AND SERVICES AS A SECTION 330 (E) FEDERALLY QUALIFIED HEALTH CENTER(FQHC) THE LEGACY CLINICS, EASTSIDE NEIGHBORHOOD MEDICAL/EASTSIDE NEIGHBORHOOD DENTAL, WESTSIDE NEIGHBORHOOD AND ISLA VISTA NEIGHBORHOOD CLINICS HAVE ALL ACHIEVED LOOK ALIKE STATUS WHICH IMPLIES THEY ALSO OPERATE UNDER THE RULES OF AN FQHC SBNC'S TARGET POPULATION INCLUDE THE LOW-INCOME, UNINSURED, HOMELESS, AND UNDERSERVED POPULATIONS (E G 63% OF SBNC PATIENTS ARE LATINO AND 74% ARE BELOW THE FEDERAL POVERTY GUIDELINE) OF SOUTH SANTA BARBARA COUNTY IN FISCAL 2015, SBNC PROVIDED 42,658 MEDICAL ENCOUNTERS AND 20,442 DENTAL ENCOUNTERS, SERVING A TOTAL OF 18,437 UNDUPLICATED PATIENTS THE MAJOR HEALTH CARE NEEDS OF THE TARGET POPULATION INCLUDE ACCESS TO AFFORDABLE MEDICAL AND DENTAL CARE, BILINGUAL AND CULTURALLY SENSITIVE SERVICES, AND MENTAL HEALTH SERVICES IN ADDITION, A MAJOR HEALTH CARE CONCERN OF OUR PATIENTS IS THE PREVALENCE OF OBESITY AND THE RESULTING DIAGNOSIS, TREATMENT, AND MONITORING OF DIABETES-ESPECIALLY IN ADOLESCENTS AMONG THE TARGET POPULATION IN OUR AREA, 21% ARE SELF-PAY/SLIDING FEE SCALE PATIENTS INCLUDING THE UNINSURED THE AFFORDABLE CARE ACT HAS DEMONSTRATED AN IMPACT OF REDUCING THE NUMBER OF UNINSURED PATIENTS SBNC IS SERVING
