Our Food Pantry also relies heavily on a large donor base of food from area churches, businesses, clubs and groups. An individual or family can visit our pantry once a week and self-select what food they desire. The pantry is managed and staffed by a team of volunteers who pour into the clients and build close ties to them as they assist them in the "shopping" process.

The Academy is A Turning Point's most unique program. Our Academy offers adults an opportunity to earn a high school diploma rather than the more traditional HiSET (GED) route. An adult's past high school transcript is assessed identifying credits needed for graduation, an individual program is created based on the deficiencies, and A Turning Point then provides all the hands-on curriculum, technology resources, and one-on-one mentoring/tutoring needed for the student to earn the credits needed. Once all requirements are completed according to MO state standards, a high school diploma is issued from A Turning Point Academy.
