Miles4Migrants is a charity that facilitates the use of frequent flyer miles to reunite refugee and asylum-seeking families. Due to the fact that frequent flyer miles are not a currency, in a traditional sense, this means that a large amount of the "value" we use as an organization is not able to be shown on our 990 forms. Through pledges of frequent flyer miles and credit card points, the organization was able to leverage 6.7 million pledged frequent flyer miles and credit card points, along with the \$19,948 we spent on taxes and fees, to fly 417 people from 163 families to safety, and their relatives, in 2018. The cash value for these flights was over \$208,000. The charity spent under \$1000 on additional costs such as website hosting, IT infrastructure, and credit card processing fees.
