There are no relationships as defined in Line 10 Section C between LMCV Liberia and LMCV America. Line 10. Grants to LMCV Liberia are divided into two major categories: Operating and Project. Operating Grants are intended for food, clothing, education, medical, hygiene, stipends and other daily living needs for raising children. 2022 Operation Grants totaled \$27,751. Project Grants are intended for capital needs such as buildings (dormitory, bathrooms, water tower, etc), repair & maintenance, and physical improvements. 2022 Project Grants totaled \$24,309. Line 16. and 31. Other Expenses included website fees, mission trip to audit orphanage, and donated shipping costs sending goods collected by Americans and Liberians in the US. All these expenses are minor program services. Line 28. Operating Grants sent monthly to enable LMCV Liberia to buy food, clothing, medicine and supplies for an average of 29 - 55 children throughout 2022. The Liberian government also recognizes LMCV Liberia as a school. The operating grants provide stipends for teachers to educate the children through ninth grade, money to purchase school supplies and send kids to BWI for high school. Line 29.
