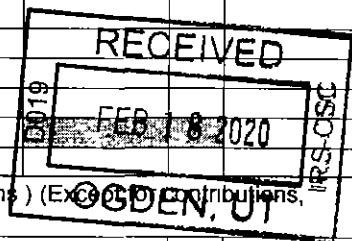

THE 2018 FORM 990-T AS ORIGINALLY FILED (COPY ATTACHED) INCLUDED AMOUNTS UNDER PART III RELATED TO UNRELATED BUSINESS TAXABLE INCOME (UBTI) FOR AMOUNTS PAID FOR FRINGE BENEFITS IN EXCESS OF THE \$1,000 DEDUCTION OF \$8,748 A SMALL CHARITABLE DEDUCTION OF \$875 WAS DEDUCTED RESULTING IN UBTI OF \$7,873 AND RESULTING TAX DUE OF \$1,653 WITH THE REPEAL OF SECTION 512(A)(7), THE SEATTLE PUBLIC LIBRARY FOUNDATION NO LONGER HAS UBTI AND HAS A \$0 TAX LIABILITY FOR 2018 AND IS REQUESTING A REFUND OF TAXES PREVIOUSLY PAID
